MIDORI PAXTON

HEAD, ECOSYSTEMS AND BIODIVERSITY, NATURE, CLIMATE AND ENERGY, UNDP

Midori Paxton is the UNDP Head of Ecosystem and Biodiversity Programme. She is responsible for a large project portfolio in over 130 countries, supporting biodiversity mainstreaming and protected area system, sustainable land management and ecosystem-based adaptation and mitigation. She oversees a range of finance initiatives including the Biodiversity Finance Initiatives, support for the Task Force on Nature-Related Financial Disclosure, The Lion's Share and the Global Fund for Coral Reefs. Midori holds a master's degree in Environment and Development from University of Cambridge, and an author of six books and hundreds of published photos and articles.

Margaret L. Kuhlow leads WWF's Finance Practice, providing strategic direction and thought and content leadership to WWF's global engagement with the finance sector. Before joining WWF, Ms. Kuhlow was Vice President of Investment Policy at the Overseas Private Investment Corporation, and was a member of the team that established and implemented the U.S. Government's Millennium Challenge Corporation, leading the new agency's approach to environmental and social assessment of major investment projects. In her 25-year career she has lived and worked extensively in developing and emerging markets, and has broad sectoral experience in sustainable investment, project finance, and grant making. She holds a Master in Public Policy, International Trade and Finance, from Harvard University's John F. Kennedy School of Government.

BÉRANGÈRE ABBA

SECRETARY OF STATE FOR BIODIVERSITY, FRANCE

Bérangère Abba is a French politician. Elected municipal councilor of Chaumont in 2014, she joined La République en Marche (LREM) then was elected Member of Parliament in the first district of Haute-Marne during the 2017 legislative elections. Since 2019, she has been secretary of the National Assembly and national delegate to LREM's ecological transition. On July 26, 2020, she was appointed Secretary of State to the Minister of Ecological Transition, in charge of biodiversity. She implements policies relating to protected areas, wildlife, hunting and water management. In charge of international relations, the World Congress of the International Union for the Conservation of Nature (IUCN) and the preparation of COP 15 in Kunming, China within the framework of the Convention on Biological Diversity will among her priorities for 2021.

PARTHA DASGUPTA

FRANK RAMSEY EMERITUS PROFESSOR OF ECONOMICS, LEAD REVIEWER OF DASGUPTA REVIEW ON THE ECONOMICS OF BIODIVERSITY, UNIVERSITY OF CAMBRIDGE

Professor Dasgupta has been a Professor of Economics at the University of Cambridge since 1985, serving as Chairman of the Faculty of Economics from 1997 to 2001. He has won numerous awards and in 2002, he was named Knight Bachelor by the Queen for services to economics. His research interests have covered welfare and development economics, the economics of technological change, population, environmental and resource economics, the theory of games, the economics of undernutrition, and the economics of social capital. In 2019, Professor Dasgupta was commissioned by HM Treasury to lead an independent, global Review on the Economics of Biodiversity. The Review's final report will be published in the autumn.

Mr. Antonio Quesada serves, since 2019, at the CNBV. At international and national arenas, he represents the Commission in several bodies. She has worked with the UN Environment Programme for over two decades and was the Director of the Law Division at UNEP. Prior to joining the Law Division, she was Deputy Director of the Ecosystems Division, in charge of coordination, operations and programme delivery. Prior to these duties, she also served as Executive Secretary of the UNEP/Secretariat of the Convention on the Conservation of Migratory Species of Wild Animals. Her work at UNEP has focused on development, implementation and enforcement of environmental laws, including multilateral environmental agreements at national, regional and international levels.
